AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in abortion, further providing for legislative intent, providing for fetal heartbeat 3 examination, further providing for medical consultation and 4 judgment, for abortion on unborn child of 24 or more weeks 5 gestational age and for reporting. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. Section 3202(b) of Title 18 of the Pennsylvania 10 Consolidated Statutes is amended by adding a paragraph to read: 11 § 3202. Legislative intent. * * * 12 1.3 (b) Conclusions. -- Reliable and convincing evidence has 14 compelled the General Assembly to conclude and the General 15 Assembly does hereby solemnly declare and find that: * * * 16 17 (6) The following: (i) Fetal heartbeat has become a key medical

- 1 <u>predictor that an unborn individual will reach live</u>
- 2 <u>birth.</u>
- 3 <u>(ii) Cardiac activity begins at a biologically</u>
- 4 <u>identifiable moment in time, normally when the fetal</u>
- 5 <u>heart is formed in the gestational sac.</u>
- 6 (iii) In order to make an informed choice about
- 7 whether to continue the pregnancy, a pregnant woman has a
- 8 <u>legitimate interest in knowing the likelihood of the</u>
- 9 <u>fetus surviving to full-term birth based upon the</u>
- 10 presence of cardiac activity.

- 12 Section 2. Title 18 is amended by adding a section to read:
- 13 § 3203.1. Fetal heartbeat examination.
- 14 Before performing an abortion, a physician shall conduct a
- 15 physical examination of the pregnant woman and her unborn child
- 16 to determine if there is a fetal heartbeat present. The
- 17 physician shall utilize the physician's best clinical judgment
- 18 to determine whether or not a fetal heartbeat is present.
- 19 Section 3. Sections 3204(a), 3211 heading, (a) and (b) (2)
- 20 and 3214(a)(1) of Title 18 are amended to read:
- 21 § 3204. Medical consultation and judgment.
- 22 (a) Abortion prohibited; exceptions. -- No abortion shall be
- 23 performed <u>after a fetal heartbeat is detected</u>. <u>If there is no</u>
- 24 fetal heartbeat, no abortion shall be performed except by a
- 25 physician after either:
- 26 (1) he determines that, in his best clinical judgment,
- 27 the abortion is necessary; or
- 28 (2) he receives what he reasonably believes to be a
- 29 written statement signed by another physician, hereinafter
- 30 called the "referring physician," certifying that in this

- 1 referring physician's best clinical judgment the abortion is
- 2 necessary.

- 4 § 3211. Abortion on unborn child [of 24 or more weeks
- 5 gestational age] after fetal heartbeat is detected.
- 6 (a) Prohibition. -- Except as provided in subsection (b), no
- 7 person shall perform or induce an abortion upon another person
- 8 when the [gestational age of the unborn child is 24 or more
- 9 weeks] <u>unborn child has a detectable fetal heartbeat</u>.
- 10 (b) Exceptions.--
- 11 * * *
- 12 (2) It shall not be a violation of subsection (a) if the
- abortion is performed by a physician and that physician
- reasonably believes, after [making a determination of the
- gestational age of the unborn child] <u>examining the pregnant</u>
- 16 woman in compliance with section 3210 (relating to
- determination of gestational age), that the unborn child [is
- less than 24 weeks gestational age] does not have a fetal_
- 19 heartbeat.

- 21 § 3214. Reporting.
- 22 (a) General rule. -- For the purpose of promotion of maternal
- 23 health and life by adding to the sum of medical and public
- 24 health knowledge through the compilation of relevant data, and
- 25 to promote the Commonwealth's interest in protection of the
- 26 unborn child, a report of each abortion performed shall be made
- 27 to the department on forms prescribed by it. The report forms
- 28 shall not identify the individual patient by name and shall
- 29 include the following information:
- 30 (1) Identification of the physician who performed the

- abortion, the concurring physician as required by section
- 2 3211(c)(2) (relating to abortion on unborn child [of 24 or
- more weeks gestational age] after fetal heartbeat is
- 4 <u>detected</u>), the second physician as required by section
- 5 3211(c)(5) and the facility where the abortion was performed
- and of the referring physician, agency or service, if any.

- 8 Section 4. This act shall take effect in 60 days.
